EXTENSION, OUTREACH & ENGAGEMENT

This section is included to highlight applied publications, presentations to lay/policy/extension audiences, and other outreach-related programming noted elsewhere in this CV.

APPLIED PUBLICATIONS

Since 2013, I have been responsible for curating or editing 127 published reports and 78 posters associated with the EEDS capstone class, which apply sustainability analysis to help community partners solve local to global sustainability challenges. These reports and posters have been authored by 289 students working in 59 research teams. Published in the OSU Knowledge Bank Campus as a Living Laboratory (CALL) digital archive, since 2013 these publications have attracted over 110,000 views and downloads, and are listed below in the Digital Publications section of the CV.

PRESENTATIONS TO LAY, POLICY, OR EXTENSION AUDIENCES

One curated public art exhibit, various videos, and online photo gallery, and three public-facing photo contests since 2018 are noted in the Video/Multi/Social-Media section, and a significant portion of the Selected Presentations and Events section below (102 presentations) involved lay, policy or extension audiences.

OTHER OUTREACH-RELATED PROGRAMMING

The RESTORExchange Religion and Sustainability Database noted in the Digital Publications section below is an outreach-oriented tool that provides access to resources to help communities become more sustainable and resilient, and it currently includes over 1,000 entries that detail various resources. This database effectively replaces the religion-ecology blogsite (also listed below in the digital publications section) as of 2022, though the blogsite continues to average over 10,000 views of its resources per year since 2018.
