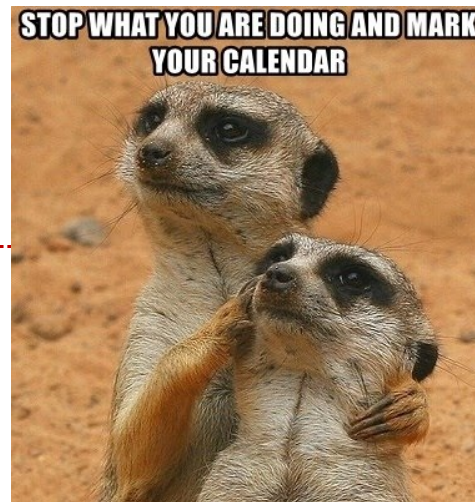

Job Opportunity

The Ohio Department of Natural Resources Division of Forestry is seeking a part-time or full-time (25-40 hours per week) intermittent (1,000 hour) Forester position to assist with Ohio's Forest Action Plan revision to start within the next 6 weeks. Per the 2008 Farm Bill, all states are required to assess the forests within their boundaries and develop strategies to address threats and improve forest health. Accordingly, the Forest Action Plans include two documents; a Forest Resource Assessment and a Forest Resource Strategy. Ohio's current Forest Action Plan, completed in 2010, is due for revision by June of 2020. The first major step in the revision process is to update the data included in the Forest Resource Assessment (this document is attached for reference and is available here: <http://forestry.ohiodnr.gov/overview>). To accomplish this task, we are seeking a current student or recent graduate (Master's student or higher preferred) that is skilled in GIS and data management and processing to start as soon as possible. Experience and/or education in forestry, natural resources management, or a related biological field is required.
