## **SENR Education Abroad Scholarship Application**

The School of Environment and Natural Resources is committed to creating and fostering knowledge around environmental sustainability. We value an interdisciplinary approach to address environmental issues and challenges at the local, regional, and global level. Education abroad provides a unique educational opportunity to apply theories and concepts learned on campus to an international context.

The School of Environment and Natural Resources is pleased to offer financial assistance for full-time, undergraduate students to participate in OSU sponsored, credit-bearing education abroad programs related to the environment and sustainability. This financial assistance, offered by SENR, is meant to reduce barriers to access for those who would otherwise be unable to participate in education abroad opportunities.

Students may apply for the School of Environment and Natural Resources Education Abroad Scholarship prior to completing an Education Abroad Application through the Office of International Affairs. If the student is selected to receive the scholarship, it will be posted to the student's statement of account. Financial assistance will be awarded in various amounts and SENR Education Abroad Scholarship funding can be received by an individual only once.

## **Selection Criteria and Requirements**

- Must be a full-time, degree-seeking undergraduate student enrolled in a SENR major.
- Must be enrolled at Ohio State University for at least one full semester at the time of application.
- Preference is given to individuals with acute financial need.
- Preference is given to individuals who have had limited or no international experience.
- Preference is given to applicants seeking to participate in ENR and closely related FAES programs.

## **Deadlines:**

Education abroad programs with application deadlines prior to December 31: scholarship applications are due by **5:00 p.m.**, **October 25, 2017**. Students will be notified whether or not they have been selected to receive a scholarship by **October 30, 2017**.

Education abroad programs with applications deadlines January 1 or after: applications are due by **5:00 p.m. December 15, 2017**. Students will be notified whether or not they've been selected by **December 22, 2017**.
