Administration graduate, David Paisley, sadly

A 1984 Parks, Recreation and Tourism

passed away on May 31, 2000, doing what he loved to do best. David was a guide working for Quest Adventures out of Colorado Springs, Colorado, and had been leading two clients on a climb of Mt. Bona in Alaska (16,000 ft. elevation). As they descended from the peak, David was testing a marked crevasse for stability and fell 60 feet to his death and final resting place (he and his wife, Patience, had agreed early in his career that no additional lives would be risked to recover a

body if a tragedy ever occurred). David was a lifelong Boy Scout and his colleagues thought him to be one of the best guides in the state of Colorado.

David will be missed. Our hearts go our to Patience on her loss.

You can say that Andrea (Sullivan) Stevenson, class of '91, is on the fast track in her environmental career. In April of this year, the Ohio Department of Transportation (ODOT) named her the new Assistant Environmental Administrator for Policy for the Office of Environmental Services. Terry Dudley is a 1973 graduate in Natural Resources (he also has an MS in Environmental Management from the University of Texas at San Antonio in 1985) and is a lifelong naturalist originally from Fremont, Ohio. Terry says that he became "alarmed with many stories of environmental deterioration" during the late 60's and the "crowning blow was when the Cuyahoga River caught on fire in Cleveland". Terry decided to attend OSU and "the rest is history!" he says. Since graduating from Ohio State, Terry has worked in the private sector. His first position was as an Environmental Specialist in Bismarck, North Dakota working with environmental compliance for a surface mining company. Terry next worked for a company out of Boise, Idaho, and Austin and San Antonio, Texas. Terry worked mostly in environmental consulting on projects dealing with a variety of mines, high speed transportation, and some overseas work. As busy as Terry was, he did watch the Buckeyes beat Texas A&M in the Cotton Bowl in 1987! Terry is married with a 14-year-old son and he and his family live on a small ranch in west Texas. "Today, I am particularly interested in working on conservation issues that affect us. Many of the same environmental challenges are still with us today, as we put even more pressure on our natural resources. A 1990 graduate in Wildlife Management, Amy has taken over the reins as Refuge Manager at the Desert National Wildlife Refuge (NWR) in Las Vegas, Nevada. Amy has worked for the US Fish and Wildlife Service since she was a student at Ohio State, working in a co-op position and then upon graduation, began as a Manager Trainee at Squaw Creek NWR in Missouri. When I joined the SNRAS, they asked me graduate degree in Web Development. As a to help on computer related projects, including the PEARL database and an alumni web site. At the time I was working in UST (underground storage tank) remediation, but I was planning on going back to school for web development. As a result, I was chosen for the job. I then created a web site for the SNRAS. At first, I was only able to create a basic web site; more advanced web design was beyond my capability at the time. As a result, I started the first web site in pure HTML (hyper-text markup language) code. It was a little rough but it contained pertinent information on the SNRAS, and was an acceptable starting point for an always-evolving website.

By the time you read this, I will have finished my schooling and acquired a

result, I am now capable of taking the SNRAS web site to new heights. The SNRAS has envisioned making the PEARLS database accessible online (with controls to restrict use by outside parties and commercial interests). The idea is to provide the alums an easy way to submit PEARLS information to the SNRAS. This will be accomplished within the next year. Michael Kirkpatrick, Systems Specialist for the SNR, is allowing the SNRAS web site to be hosted on the SNR server. Michael is currently switching over to a Linux-based Apache web server. When this occurs, I will be able to write the code for online registration for the PEARL database. I also will be able to post other forms on the site, such as questionnaires.

Another direction we want to take is to have a LISTSERV for the alums. This will allow the SNRAS to give the alums information on current events in a timely fashion. This is a great way for alums to keep connected with OSU and the SNRAS through e-mail.

Other projects will include the SNRAS Newsletter to be offered in text only format online. As some of you now know the Newsletter is currently online, but in a slowloading .pdf format. In the near future, the web site will have gone through a major overhaul. The newer technologies I am now using will be incorporated to provide a more practical and visually-appealing web site.
