# History, Ecology, and Sustainability of Large Rivers:

#### Overview:

Large floodplain river systems are dynamic and diverse ecosystems that have played a major part in human history. In this course, we will explore the interactions of human activities and river systems over space and time. Specifically, we will delve into (1) the role of large river systems in shaping patterns of human settlement, and networks of biological and economic exchange; (2) the ecology of large floodplain rivers; and (3) the sustainability of large rivers under growing environmental stressors including increasing energy demands, land-use and climate change, and water pollution. Readings will be drawn from the primary scientific literature, historical accounts, and popular texts.
