Taxonomy and Behavior of Aquatic Invertebrates Spring 2024

COURSE OVERVIEW

This course investigates the taxonomy and behavior of freshwater aquatic invertebrates. to freshwater systems and its abiotic and biotic components. During the semester we will look at general morphology, taxonomy, phylogeny, ecology, behavior, adaptations, and diversity of freshwater aquatic invertebrates. Students will demonstrate lab and field techniques during the semester to collect invertebrate data for biomonitoring and curate their own collections.

Quizzes

There will be a pre-laboratory quiz each week covering Order, Family, Genus and Common name as well as key characters. These will be short (around 5 questions) lab practicals and be in person at the start of lab. If you do not show up or are late to lab, you may not take the quiz. I will drop your lowest quiz grade, only if you complete all the quizzes during the semester (i.e. If you are absent from a lab, you cannot drop that quiz grade of 0%).

Poster Presentations

Students will work in groups of 2 people to analyze and present data collected by the individuals or groups. Projects must be bioassessment focused using aquatic invertebrates but can also be diverse and applied to other streams, watersheds, or areas. Rubric will be uploaded to Carmen. I will work with each group to come up with a project by March 1.
